Council Member Yanda asked if the first offense is a warning and does the judge determine the amount? Mr. Crosby stated in most cases, the first offense will not result in a citation.

Council Member Selby asked if the fine could be tiered by first offense, second offense and so on. Mr. Miller stated the tiers would take away the discretion of the officer and judge.


