Community Development Director Mitch Hort advised the Council that the addresses remaining to be considered were: 401 Annawood; 221 Birch; 211 E Cherry St; 417 S 8th St.; 901 Glenwood Dr; 701 John F. Kroutil Dr; 4300 N Mustang Rd; 760 Okieridge Rd; 104 Pine; 6 Spruce Dr; 3 Spruce Dr; and 632 Woodlawn Dr. Pictures of the properties were presented for the Council's review.

Ms. Bobbi Elledge, of 701 John F Kroutil Dr., addressed the Council and stated that the swimming pool was currently undergoing repairs after contractors from last year did not finish the repair work started at that time. Mayor Bradway offered to give her until August 1 to complete repairs. The motion to allow the property at 701 John F Kroutil Dr until August 3, 2010 to complete repairs was made by Council Member Tipps.

Mr. Gary Borneman of 617 John F Kroutil informed the Council that this situation has been ongoing for 18 years, and provided a brief history of the pattern. Mayor Bradway asked Director Hort to monitor the situation and assess fines if needed. Ms. Laura Borneman of 617 Kroutil also asked the Mayor what she could do to insure she did not have to come to the Council with the same complaint in the future. Mayor Bradway explained that Mr. Hort would monitor the pool year-round and the pool must remain in compliance.

City Attorney Mike Segler advised the Mayor that the owner of 632 Woodlawn has passed away. The property's attorney stated that a representative for the estate would be appointed on July 26th, and asked for an additional week to address the problem at that address. Mr. Hort advised that there had been abatements at the property for at least 15 years. Mayor Bradway asked Mr. Hort to monitor this address as well.

Council Member Maxey seconded the earlier motion from Council Member Tipps to allow the owners of 701 John F. Kroutil Dr. until August 3, 2010, to complete their pool repairs.
