CITY COUNCIL MINUTES December 29, 1999

The Yukon City Council met in special session on December 29, 1999, at 10 a.m., in the Council Chambers of the Centennial Building, 12 South Fifth.

1. Consider Authorizing City Manager to Purchase Following Items:

A. Verdin Clock and Bell Tower

B. Planet Electric Cargo One Utility Vehicle

C. ATLV 4300 Diesel Street Sweeper

A. Verdin Clock and Bell Tower. Mayor Taylor stated this is something the Millennium Committee has been working on for sometime, and we need to order this by today to lock in the price of \$23,110. Mayor Taylor stated bricks for the base of the clock would be sold to help offset the cost.

Mayor Taylor made a motion, seconded by Council Member Vinson, to approve the purchase of a Verdin Clock and Bell Tower at the cost of \$23,110.

Council Member Vinson asked if a price at been set for the bricks.

Mayor Taylor stated they would be around \$25 each, depending on the height and weight of the clock and how many we would need. Mayor Taylor stated that up to four major donors' names could be inscribed on the face of the clock if we wished. It was stated that the money received from Duke Energy for holding their energy site, plus the Nextel contract money, would be used to help pay for the clock. It will not be paid for with taxpayers' money.

Council Member Vinson stated she didn't feel these names should be on the clock. City

Manager stated they would not be.

The vote:

B. Planet Electric Cargo One Utility Vehicle

Total cost of this unit is \$14,500. City Manager stated this will mostly be used in the Park Department and for parades. He also advised there is no one locally that owns one of these units for him to check with regarding upkeep, etc.

A motion was made by Weller, seconded by Vinson, to authorize the City Manager to purchase a Planet electric cargo one utility vehicle for a cost of \$14,500.

C. ATLV 4300 Diesel Street Sweeper

Mayor Taylor advised the Council Members who attended the National League of Cities conference saw a demo of this sweeper, and they feel it will be a good purchase for the City. Sale price of this sweeper is \$26,332.45.

COUNCIL MEMBER MYERS ARRIVED AT MEETING AT 10:12 A.M.

Mayor Taylor stated you can attach a hose to this sweeper and clean the fence rows.

Council Member Vinson made a motion to approve the purchase of an ATLV 4300 diesel street sweeper; second made by Council Member Weller.

Council Member Weller asked if this unit would be brought in on a trial basis before purchasing.

City Manager said he thought since there is a 90-day guarantee, it would not be necessary to do so. He stated he would suggest that we purchase it on the recommendation of others that he has talked with.

Mayor Taylor stated We have been looking for a street sweeper for about two years at costs of up to \$80,000, so he feels this is a bargain.

The vote on the motion:
