2. Report of Boards, Commissions and City Officials

City Manager Jim Crosby stated that Highway 92 is now open, with exception of a small portion where there is work to still be completed. He advised that new businesses in this vicinity will be opening soon, and there is one restaurant under construction. He stated we are hoping to see things moving forward guickly with the good weather.

An update on the Holly/Vandament intersection was given. Mr. Crosby stated all easements should be obtained within the next 2-3 weeks, then the utility lines will have to be moved before construction can begin.

Jan Scott appeared before the Council to remind everyone that the spring craft fair and flea market will be this Saturday at the Dale Robertson Center.

Ms. Vinson urged everyone to support Special Olympics fund raisers this coming week, stating they have a lot of fun activities planned.

Ms. Vinson reminded everyone that Staples will hold its pre-grand opening this Friday.

Vice Mayor Vinson offered her congratulations to Dewayne Maxey.

Mayor Friesen commended Council Member Rundel for his web site.

Mayor Friesen stated he had received information that the current ambulance service has pulled the \$90 membership offer due to potential concerns that they feel are in conflict with Medicare. However, current members will not be charged any additional money or have any changes in membership through the end of May, 2001.

City Manager Jim Crosby stated that there is a question regarding ambulance service because Mercy is now asking all cities and towns where they have ambulances stationed to subsidize them. He stated we do not know the amount they are asking at this time.

The City Manager stated he also wanted to comment on the security at City Hall, as he was questioned regarding this by the council. He stated an item was placed in his desk for safe keeping, and it is now missing. He stated we are adding security for after hours. Mr. Crosby assured everyone that nothing was missing from anyone's personnel files.
