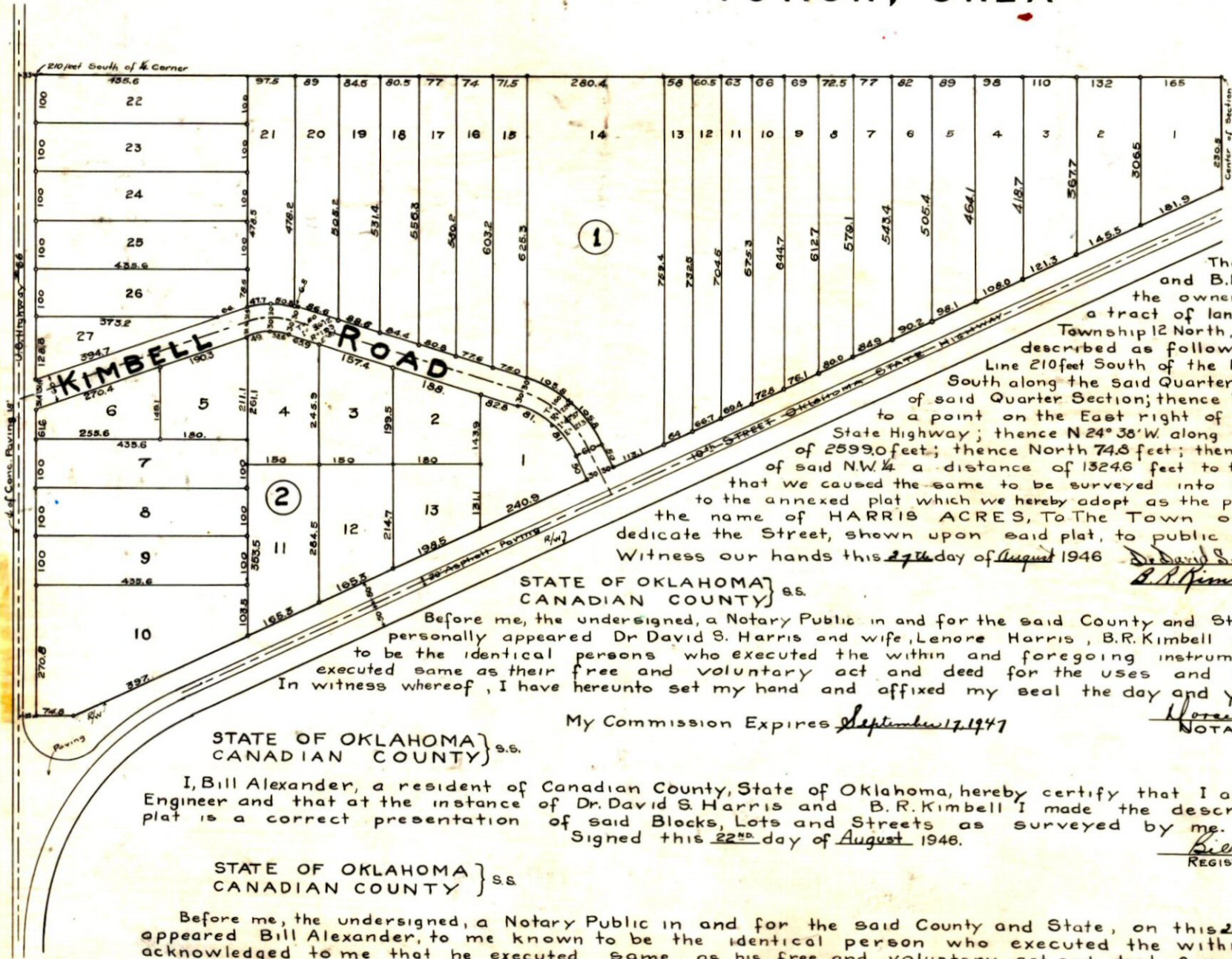

That Dr. David S. Harris, Lenore Harris, his wife and B.R. Kimbell and Blanche Kimbell, his wife, being the owners of the following described property to wit: a tract of land lying in the East 1/2 of the NW 1/4 in Section 21, Township 12 North, Range 5 West of the I.M. More particularly described as follows: beginning at a point on the Quarter Section Line 210 feet South of the N.E. Corner of the NW 1/4 of Section 21; thence South along the said Quarter Section Line 2432 feet to the South line of said Quarter Section; thence West along the said South line 230.5 feet to a point on the East right of way line of the Tenth Street Oklahoma State Highway; thence N 24° 38' W. along the East line of said Highway a distance of 2599.0 feet; thence North 74.8 feet; thence East and parallel with the North line of said N.W. 1/4 a distance of 1324.6 feet to the point of beginning, do hereby certify that we caused the same to be surveyed into blocks, lots and streets in conformity to the annexed plat which we hereby adopt as the plat of the above described land under the name of HARRIS ACRES, To The Town of YUKON, OKLAHOMA and do hereby dedicate the Street, shown upon said plat, to public use.
