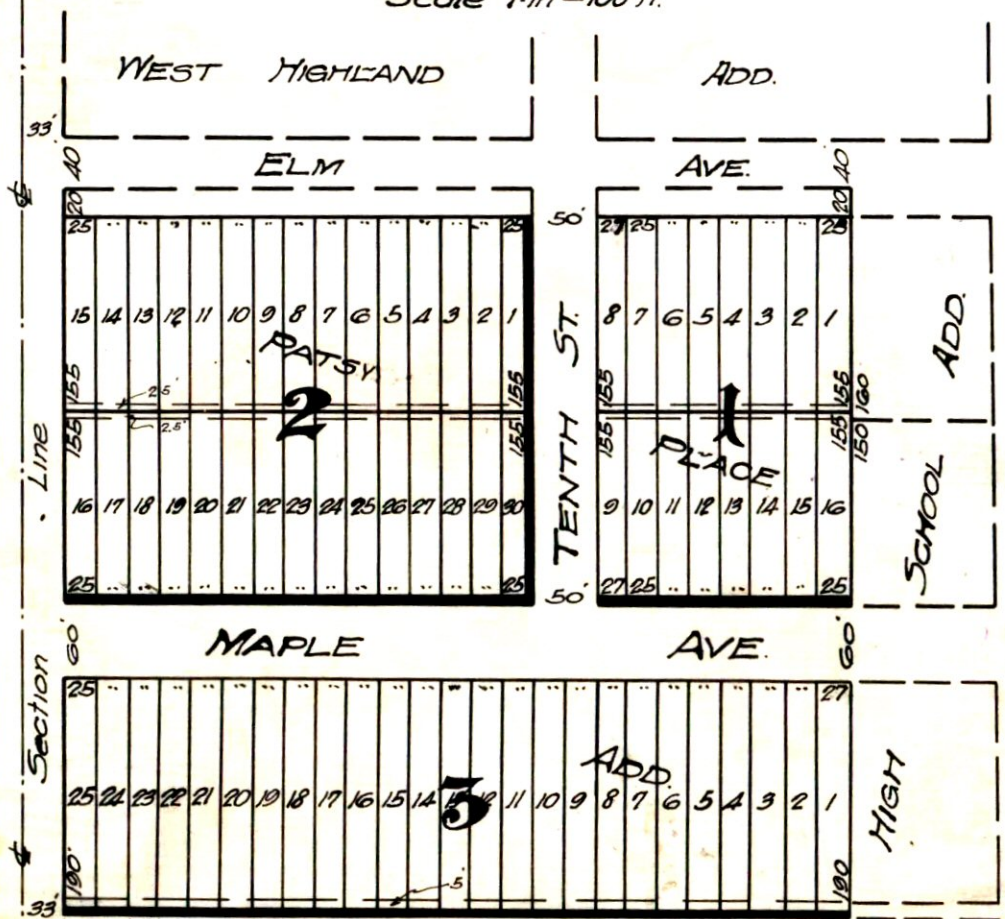


PATSY PLACE ADD.

To All Men By These Presents:  
That we, Ethel Dobry and husband, Joe E. Dobry being the owners  
of the following described land, to wit:-  
A portion of the West Half of NW 1/4 of Sec. 20, T. 12 N. R. 5 W. 1. M. more particularly  
bounded and described as follows: Beginning at a point 390 feet South and 640 feet East of the  
Northwest corner of the Northwest Quarter (NW 1/4) of Section 20 in Township 12 North of Range 5  
West 1. M. being the Northwest corner of High School Addition, running thence West 627 feet to  
the Section line, thence South along said section line 580 feet, thence East 627 feet to  
the Southwest corner of High School Addition, thence North along the West line of said  
High School Addition 580 feet to the place of beginning.  
Do hereby certify that we have caused the same to be surveyed into lots,  
blocks, streets and utility easement in conformity to annexed plat which we hereby  
adopt as the plat of the above described land under the name of Patsy Place Addition  
to the City of Yukon Oklahoma and do hereby dedicate all of the streets and easement
