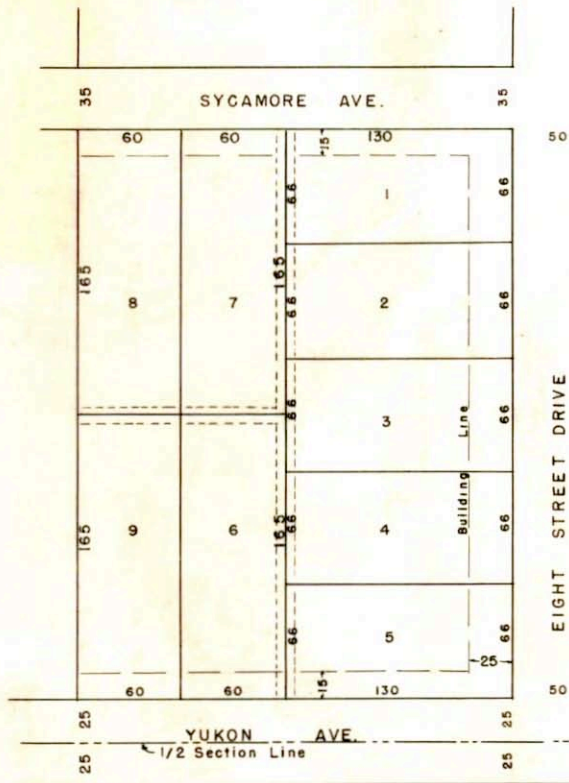


VOGEL ADDITION YUKON, OKLAHOMA
